 y^e sd John Mosier for & in Concideration of a valueable sum of Money
 in hand received Hath given granted bargained & sould and by thes
 presents doth give grante bargaine & sell a certaine [a certaine] parcell
 of land scituate & being at a place Called the old field by Computation
 four acres or thereabouts next adjoyning to the land in the tenure &
 occupation of John Jenner on y^e west To y^e land in y^e occupation of
 Joseph Tooker on the south the East & north sides being next the
 banke near the sound To HAVE & TO HOLD the sd land with its prive-
 ledges in any wise thereunto appertaining unto the sd Samuell his
 heires Executors Administrators or Assignes for ever to his & their
 use & behoofe And the sd John Mosier doth for himselfe his Heires or
 Assignes hereby Covenant promise & grante to & with the sd Samuell
 Eborne to warrant & defend the title of the sd land against any laying
 any claime there unto & to Discharge the same from any Dues demands
 or Incumberance what soever & if need require to give any farther
 Confirmation of the same Jn Witnesse wherof the sd John Mosier &
 Elizabeth his wife have hereunto set their hands & seales the day &
 year above written

Dayton doe by thes presents freely & firmly Give grante alienate & make over unto the sd William Weatherby To him his Heires Executors Administrators and Assignes to Have and to Hold for ever Without any let hinderance or Molestation by me or mine laying any Claime to any parte of the same but to be to him & to his use for ever which J doe freely give unto him for parte of his Portion with my Daughter Sarah further if need require J doe promise to Asigne any firmer Deeds of Conveyance for the Ratifying & Confirming this my Deed of Gift To the true Confirmation hereof J doe set to my hand & fix my seale at Brookhaven south this 15th of May 1688

This Indenture made the twenty first day of August in the third year of the Reigne of our Sovereigne lord James y^e second by the grace of God of England &c King Defender of y^e ffaith &c Between John Tucker Jun^r of Brookhaven in y^e County of Suffolke on Long Island in the Province of Newyorke of y^e one Parte and Moses Owen of the sd Towne & County of the other parte Witnesseth That y^e sd John Tucker for causes him thereunto moving Especially for a valueable sum of money Already received (the Receite wherof the sd John Tucker doth hereby acknowledge and him the sd Moses Owen doth hereby acquit & discharge from every parte & parcell therof) Hath given granted bargained aliened & Confirmed and by thes presents doth give grante bargain alien & Confirme unto the sd Moses Owen & his Heires for ever a Certeine house & home lotte scituate & being in the Towne of Brookhaven abovesd Joyning to a hygh way by Thomas Jenners home lot on y^e north side And to the land of
