SAMUEL TERRILL OF EASTHAMPTON AND BROOKHAVEN: COLONIAL BLACKSMITH

The surname of Terrill appears in Suffolk County history from the seventeenth century to the present day and is honored in the place name of the Terrell River. This article will cover only the colonial period of Long Island as it relates to Samuel Terrill and his probable early descendants.

Samuel Terrill was baptised on October 31, 1647 in Milford, Connecticut. He was the son of Roger Terrill and Abigail (Ufford).¹ Samuel is first reported living in Easthampton in 1678 according to their tax rolls. A blacksmith by trade, Samuel was engaged by the town of Brookhaven in 1680 to come and practice his trade there for three years as a condition of receiving land. He was to be given twenty acres of land, seven for a home lot, five acres in the little Neck, and the rest of the land to be located in the new southwest division (Setauket). Blacksmiths were important citizens of colonial America. Whilst we think of them for their farrier work in the shoeing of horses and oxen, they were also important for the nails, primitive tools and other items necessary for an agricultural economy.

Samuel left behind in Easthampton his younger brother Thomas who was also a blacksmith. In 1694 Thomas Terrill sold eight

acres of land to Robert Hudson who was probably his apprentice. Robert Hudson was a nephew of Samuel and Thomas Terrill; he was the natural child of Hannah Terrill and Robert Hudson of Rye, New York. Thomas Terrill moved to Rahway, New Jersey, and later to Elizabeth, Essex County, where he and his sons continued the blacksmith trade.²

By April 1681 the town meeting of Brookhaven voted and agreed to the land arrangements that were paramount to Samuel residing in Brookhaven. Samuel continued to acquire more land; in 1682 Thomas Biggs arranged to take five pounds worth of trade in blacksmithing for partial payment of land. In 1684 Robert Goulsberg sold to Samuel a half "commeg"--a common lot. If this common lot was marsh land, Samuel would find it very useful for the purpose of thatching roofs.

In January 1684 Samuel and Abigail had a son Samuel, and his birth was duly reported in the Brookhaven town record. Infant life was uncertain in those days. On April 29, 1685 Abigail agreed to take into lodging the seven month old daughter of Benjamin Gould. (The mother had probably died.) Baby girl Gould died less than a month later and was buried on the 19th of May.

Family tradition has claimed Indian heritage in the Samuel Terrill line; i.e., "the original Terrill married an Indian, possibly of the Nissequoge tribe."³ This legend may have originated in the Indian deed by Wophege given on December 13, 1688 to Samuel Terrill for land in an area on Yamphank Neck. Wophege granted the land "...for and in consideration of ye good will and Affection which I have & Doe Bare unto Samuel Terrill..." The deed later mentions "sundry gifts and benefits" received from Samuel.

Samuel's relationships with the Indians were not always friendly. On July 7, 1686 Samuel, along with Samuel Dayton, Jonathan Rose and Walter Jones, had to appear before the Governor General's Council regarding a petition from the Indian, Tachanick. Tachanick had objected that the inhabitants of Brookhaven had built houses and broken up land without any satisfaction to him.

Misfortune struck the Samuel Terrill family on December 1, 1698. "By a fire kindled in the thatch of his house" all his goods, clothes and provisions were destroyed. His fellow townsmen petitioned the Earl of Bellmont, the colonial Governor: "that he, Samuel, having a wife and six small children...be granted authority for the collecting and receiving the charity of well disposed persons." Signators included Richard Smith, Adam Smith, John Tuthill, Matthew Helm (fourteen in total).⁴

Immediately afterwards there was a flurry of land sales as Samuel Terrill sold off property in order to raise money. In 1701 it was

reported that Samuel had moved from Brookhaven. In 1704 Samuel sold to his brother Daniel land that he had inherited from his father Roger. It appears from witnessing agreements that they signed that Samuel and his wife Abigail were living in East Moriches. In 1706 Samuel bought land from Henry Smith. The last known land transaction that Samuel made was in 1714 when land in Warranta (Waracto Neck) was sold to Sarah Conklin. At that time, Samuel would have been 67 years old.

What happened to the six small children? How did they grow up, and where did they go? First of all, Samuel, Jr., is the only one that can be positively identified as belonging to this family. Samuel Terrill, Jr., was married to Abigail Baldwin in Milford, CT, on August 17, 1710. They had a son Lemuel born Sept. 10, 1711.⁵ The Brookhaven town record reports that the town received a petition in 1731 because of "half rights" of a common lot not being used by Samuel Terrill. Samuel, Jr., must have returned to Long Island later, for in 1738 he was granted a permit to be proprietor and owner of Yamphank Neck. This was the parcel of land that Samuel, Sr., had been deeded by the Indian Wophege. The son of Samuel, Jr., was also a Samuel and a weaver by trade. From his will made in 1765 he can be identified as a member of this family for he makes arrangements to care for his brother Lemuel.⁶

Adam Terrill, Yeoman, of Wading River was a probable son of the first Samuel. Adam first appears in the Brookhaven town records in 1717 regarding a land purchase in Wading River. In 1727 he received property from the town clerk, Daniel Brewster; this property could have been land owned by Samuel, Senior. Adam was listed in the 1741 tax rolls. The last notice we have of Adam Terrill in Suffolk County is an unsigned deed for a half "commage" of land in Wading River in 1749. Many of these land transactions involved either the Daytons or Robert Hudson of Easthampton.⁷ In 1753 in South Jersey Adam Terrill's name appears on the purchase of sale of parsonage land for a Presbyterian Church. The other signatures on this document include many surnames familiar to Long Island. They include Jonas Dayton, Samuel Leek, Nehemiah Veal and Abraham Rose.⁸ Was it possible that an entire boatload of Long Island settlers sailed to South Jersey to start a new life for themselves there?

A John Terrill first appeared in the 1707 Brookhaven town records when his wife "Philadelphia" inherited some land in Lyme, CT. Could he have been a son of Samuel? He does seem to have had some of the same propensity for bad luck as Samuel, Sr. On January 22, 1721 Brookhaven town paid ten shillings for the relief of John Terrill's wife and children. Did John go to sea and not return for the winter? By November 24, 1722 he had returned and witnessed a quit claim deed made by Issac Dayton, Jr., after the death of his father Issac, Sr. The deed is recorded in Brookhaven; the deed may have been signed

either there or in New Haven, CT. The years must have been kinder to the John Terrill family. Twenty-two years later they were living in Lyme, CT, and John and Philadelphia gave property to their son John.⁹

James Terrill of Brookhaven and Hunterdon County, Jersey, was another possible son of Samuel. In 1719 James and his wife Joyce Bryant received property from her father. James died at a rather young age on December 12, 1728 in Hopewell Township, Hunterdon, West Jersey. He left three small children.¹⁰

Life was not easy for our colonial ancestors. They moved frequently across both Long Island Sound and down into the Jerseys, probably for a combination of family and economic reasons. This concludes the background on the early Terrills in Brookhaven. There were also Terrills living in the Southold area during the same time, but no relationship between the two family groups has been established.

JOHN TERRILL OF BROOKHAVEN AND LYME, CT: AN UPDATE

Audrey Terrill MacLellan, in her recent article on Samuel Terrill, examined the question of whether John Terrill of Brookhaven, who later moved to Lyme, Connecticut, was a son of Samuel ("Samuel Terrill of Easthampton and Brookhaven: Colonial Blacksmith", *SCHS Register*, vol. XXII, no. 3, Winter 1996, pp. 83-86). While circumstances suggested he was Samuel's son, definite evidence was not available.

We are happy to report that proof has now come to light. In the Society's Library is a transcript of a journal made by Gurdon Saltonstall in January 1745 ("Journal from New London to Brookhaven & South: Began Jan'y 21st 1744/5", manuscript copy and transcribed copy, as taken from File No. 10755-1944, Cameron Estates Inc. vs. George T. Deering et al, Suffolk County Clerk's Office). Saltonstall was apparently conducting a survey of the bounds of Winthrop's Patent in Suffolk County for the Winthrop family of New London, Connecticut. On 28 January his entry concerned lands which "Old Samuel Terrell" had sold to Jonathan Rose. Regarding this transaction, the journal notes "Ancient Witnesses probably Living-John Terrell Son of Sam at Lime in Conecticut..." (Ibid., p.5).
